5) Introduction of new Courses:

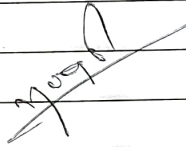
Miss. Saba Ansari requested the Committee that we shall introduce new programs from the Next academic year.

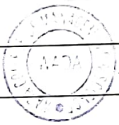

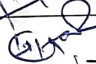
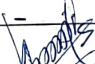
